**Designation to Local Register:** As a result of the public hearing, the following properties were listed on the Local Register.

Motion by Houck with a second by Marshall to nominated the Bowen D. Houck residence, 420 East Court Street to be listed on the Richland Center Historic Properties Register. Motion carried unanimously.

Motion by Meadows with a second by Kepler to nominate the James E. Pollard residence, 220 East Union Street to be listed on the Local Register of Historic Properties. Motion carried unanimously.

Motion by Sandmire with a second by Meadows to nominate the City Auditorium to be listed on the Local Register of Historic Properties. Motion carried unanimously.

Plaques will be given to these home owners to be placed on the property. It was suggested to also mail the property owner a congratulation letter. Later in the spring a press release will be issued.

**Update on Educational brochures and plaques**: 500 brochures have been printed. They will be distributed to Council members, Chamber/Main Street offices and the Library. Kepler thought some should be mailed. Edwards suggested we mail one out to each contributing property listed in the City's historical survey when setting up our informational meeting in the spring. Marshall thought it better not to mail them out, rather have them available as a handout at the meeting in March.

The plaques have been ordered and should be here by the end of the year.

Future listing on Local Register - 1987 survey list: Some of the properties that were suggested were: Dr. Delventhal, Dr. Edwards, Passages. Bower will speak to Dr. Delventhal, Edwards will speak to Sonia at Passages, and Houck will contact Dr. Edwards.

**Update on becoming a Certified Local Government:** Most of the information has been gathered for Certification and will be sent in soon.

# HISTORIC PRESERVATION COMMISSION PUBLIC HEARING

November 30, 1998 6:30 P. M.

The public hearing was called to order at 6:40 P. M. by Commission President Jerry Bower to place three properties on the local historic register. President Bower explained that he would like each speaker to state their name prior to their comments. Comments would be solicited alternately between those "in favor" and those "opposed" to the designation.

The following properties have been nominated by the Richland Center Historic Preservation Commission to be placed on the Local Historic Register:

President Bower: The first listing is the Bowen D. Houck residence at 420 East Court Street, Richland Center

Would anyone like to speak for the nomination? (Ask 3 times for each)

Kent Houck: Kent introduced John Houck, Bowen's son. John takes care of his father's

financial affairs and is listed as a contact on the tax records. Kent is Bowen's brother. Kent reviewed the property and the owners history. The property is

historically and architecturally significant per the 1987 City survey.

John Houck: John mentioned he did not receive a notice of the public hearing. He also asked if

getting a clearance from the Historic Preservation Commission would be necessary prior to receiving a building permit. Jerry explained it may take longer, but a special meeting of the Historic Preservation Commission would be called. The

process could take a month.

President Bower: Would anyone like to speak against the nomination? (3 times)

President Bower: The second listing is the James E. Pollard residence at 220 East Union Street,

Richland Center. Bower reviewed the property and said that this property is already listed both on the National and State Register of Historic Properties.

President Bower: Would anyone like to speak for the nomination? (3 times)

Twylah Kepler: Kepler explained the property is also important because of Julia Bowen who was

the first president of the Women's suffrage movement.

President Bower: Would anyone like to speak against the nomination? (3 times)

President Bower: The third listing is: The City Auditorium at 182 N. Central Ave, Richland

Center. Bower explained this property is also already listed both on the

National and State Register of Historic Properties.

President Bower: Would anyone like to speak for the nomination? (3 times)

Twylah Kepler: Kepler explained we should recognize that it was the first municipal auditorium

built in Wisconsin.

President Bower: Would anyone like to speak against the nomination? (3 times)

Alderperson Culver: Culver explained he was not speaking against nomination, but was wondering if we shouldn't wait six months before putting it on the register?

Luella Edwards: Edwards explained the City is now required by the State to secure the state approval on any alterations, either inside or outside.

Twylah Kepler: Kepler wondered if new owners would have any restrictions?

President Bower: Would anyone else with to speak?

Houck suggested having out of town speakers come to a meeting to speak to people who have been invited because their properties could be listed on the local register. This will be checked into for a meeting in 1999.

**CERTIFIED LOCAL GOVERNMENT (CLG) STATUS:** Edwards stated all of the information has been gathered and the Mayor's office will be submitting the letter of request to the state early in November.

**PLAQUES:** Bower brought several catalogs along with five price quotes from suppliers. It was decided additional information should be requested from the low bidder, Erie Landmark Co.

**Set Public Hearing**: No public hearing was set.

It would be optional for the home owner to have one, but the cost would be covered by the Commission. Bower will check further into costs if several are purchased at one time.

# Future listings on Local Register:

a. Establish form for listing.

The Commission reviewed the form for listing on the National and State Register and made changes pertinent to Richland Center. A motion was made by Bower, second by Meadows to approve the form as reviewed for listing properties on the local register. Moser will print a form with recommended changes and Houck will check it over, and bring it back to the next meeting.

b. Narratives from Property lists. All narratives are in except one. That will be finished soon and can be distributed to the members.

# Update on becoming a CLG (Certified Local Government)

a. Member biography. All biographies are in and most other requirements have been met.

**Set Public Hearing**: It was originally thought that the Public Hearing for the new listings for the local register would be held during the October meeting. Due to the fact that the notice must appear in the local paper for two weeks plus a waiting period, it won't be possible to get all information together before October 5 which would be the date to have it to the Observer for publishing. Therefore it was decided to postpone the hearing until the November meeting.

**Reports, Requests, etc.** The Wisconsin Association of Historic Preservation Commissions and the State Historical Society of Wisconsin Fall Workshop will the held on October 24, 1998 in the G. A. R. Room of the State Capitol in Madison. Bower will plan to attend and urged other commission members to go if they can. Marshall and Meadows asked for some direction on what kind of brochure they should focus on-what is historic preservation verses historic properties, etc.

(Meadows would like to see the historic building code. Edwards will check with McCorkle to see if he has a copy.) Copies will be sent to each of the memebers.

Bower feels there are three goals we should achieve with our brochures:

- 1. Introduce the commission and preservation. (Similar to Mazomanie and LaCrosse)
- 2. Blend the two items in one brochure.
- 3. Educate the community about the brochure.

Listing of properties on the local register: Marshall said Bob Jones approached him again about putting his property on the local register.

Glanzer visited with the commission prior to the beginning of the meeting. Glanzer said he would be interested in listing on the local historic register his properties: the Warehouse, Krouskop Mansion, and his other house across the street from the Warehouse (Banker house).

Other properties mentioned to put on the local register were: Pollard's house (E. Union St); Laue's house (420 N. Park St); the Kirkpatrick house (N. Sheldon St); and the Bowen Houck house (420 E. Court St.)

Marshall will put some pictures together of Pollards and Jones houses and the Warehouse for the brochure. Meadows will work on the narrative.

Houck mentioned the Lewis House. He will talk to them to see if they are interested in having their home listed on the local historic register.

Edwards suggested City Hall be added to the register. Houck will check with Bowen Houck and Kepler will check with Helen Strang to see if they would be interested in having their homes listed on the local register.

Marshall said there is a market now for historic homes which have been restored.

Bower mentioned LaCrosse's idea of purchasing a plaque for each property on the local register. He felt it would be a good idea for us also. Meadows has information on plaques.

Edwards is to send a letter to each property owner who wished to be on the local register along with a copy of the preservation ordinance.

Update on CLG (Certified Local Government): Edwards and Bower will work on the requirements and report to the commission at the next meeting. It is the feeling we will be a CLG by year's end.

**Reports:** Kepler distributed narrative on three properties she viewed from her list. Other members will prepare narratives of their lists and bring them to the next commission meeting.

Meadows passed around a postcard Richland Main Street Design Committee uses to inform people of their grant program. Marshall feels we shouldn't have to reinvent the wheel to create a brochure. (architecturally or historically)

Bower asked for help in collecting brochures from other communities. Meadows will work with Edwards in obtaining brochures.

There was a motion by Pierson, second by Pollard to cast a unanimous ballot for Marshall and Meadows. Motion carried.

Create Public Education Program: Due to the length of discussion on the Ordinance, Bower suggested the Public Education Program be taken up at the next meeting of the Commission.

Proposal to list Railroad Depot on the State and Federal Register: Joan Rausch of Architectural Researches, Inc. of LaCrosse, WI has submitted a proposal to furnish the National Register of Historic Places nomination for the C. M. & St.P Railroad Depot in Richland Center for a contract fee of \$1460.00. Ms. Rausch is the Historic Consultant that did our Survey in

1987, and her fee is below her usual amount due to prior work in the community. Motion was made by Pierson, second by Meadows to recommend to the City Council to hire Rausch to pursue the Historic Registration. Motion carried. The federal and state historic registration will be required when the City is awarded the ISTEA Grant.

Wisconsin Association of Historical Society Commissions Membership: The Wisconsin Association of Historic Preservation Commissions offers updates, newsletters, resources, and networking to help the Commission stay abreast of issues and be an active part of the Community. It was felt that membership in this organization would be very helpful to this group. There was a motion by Marshall, second by Pierson to join the State Commission for an annual fee of \$40. Motion carried.

**Reports, Requests:** Bower reported that he will be attending the Wisconsin Association of Historic Preservation Commissions Spring Workshop on Saturday April 4, 1998 in Madison, Wisconsin. Information was also handed out about the 1998 Heritage Tourism Conference which will be held May 14-15, 1998 in Fond du Lac.

McCorkle stated we should notate calendar days if it is calendar days. Bower instructed him to add a definition of "days" to the ordinance. Draft #2 of the historic preservation ordinance amendment was reviewed in its entirety. Changes will be made and issued as Draft #3. Draft #3 will be mailed to the commission members along with the public hearing minutes. The amended Historic Preservation Ordinance will be placed on the February 16th council agenda.

#### Commission members discussed the following:

Pierson- What in the ordinance will set aside Carson's fear of the city paying court costs? What about the issue of property owners losing rights

Bower- I don't see why this issue is any different than zoning which some feel takes away property owners' rights.

Meadows- Historic Preservation has a monetary value. I own two historic buildings and so I understand.

Marshall- I don't think we should be concerned about the perceived loss of property rights.

Elliott- It may be fine but I see great problems. You are severely limiting what I can do with my property.

Pierson- Are we going to force people to follow all these rules?

Meadows- We aren't going to force anyone.

Kepler- The new owner of the old "Benson" house came to see me and they want to put aluminum siding on the house. I understand they want to do this for insulation and yet that certainly would not be allowed by this ordinance.

**Reports and Requests:** Edwards asked the commission for a suggestion for a replacement for the architect's position on the commission. No architects were suggested, but Pierson suggested Steve Mills as a citizen member.

**Future Meeting Dates:** The Commission meets at 6:30 P.M. on the fourth Tuesday of each month. The next meeting will be February 24, 1998.

There being no further business to come before the Commission, there was a motion by Kepler, second by Marshall to adjourned. Motion carried and meeting adjourned at 8:40 P.M.

#### PUBLIC HEARING MINUTES

The public hearing was called to order at 6:37 P.M. by Commission President Jerry Bower to place the Railroad Depot on the local historic register. President Bower explained that he would like each speaker to state their name prior to their comments. Comments would be solicited alternately between those "in favor" and those "opposed" to the designation.

President Bower:

Would anyone like to speak in favor of designating the Railroad depot to

the local historic register?

Madonna Kinkaid:

I am a native to the area and a property owner near the depot

I have some comments relating to the history of the railroad in

Richland County (see printed text attached). I will also read to you from Mabel McNurlin's 1897 diary. I do believe it is possible to preserve the

depot.

President Bower:

Would anyone like to speak in opposition to the depot's designation.

(No response)

Following are remarks by individuals who spoke in favor of the designation:

Sue Leyda:

When the uncertain future of the depot became known, many people came forward to volunteer their help. The depot is a tourist attraction. Please don't tear it down. We

must respect this building and designate it as a local historical landmark.

Bob Simpson:

What will you do with the depot?

President Bower:

Our hearing will only address the historic designation of the depot.

Carol Stevenson:

I am on a committee to save the depot and also sit on the Chamber Board.

My husband, Steve, and I are building a museum on our land. My grandfather was a train engineer. We have many historical buildings in Richland Center, but we have also lost many historic buildings. I think history and progress can go hand in hand. It wouldn't be the same if we

replaced it with a fake.

Jude Elliott:

I am all for the depot, but I think that Main Street should look at the area. Have you looked at neighbors and joint ownership of the driveway? It isn't very attractive right now. You have a problem next door (there are 2 houses and another building with junk cars) and it doesn't look very nice. Those problems should be addressed before you go spending money.

I'm not against listing the depot.

Twyla Kepler: Rumors have it the building will be moved 4' because of the highway project.

Bill McCorkle: Those are only rumors. The City has draft plans of the highway project and it doesn't show the depot being relocated. When we get final plans I will show them to you.

Larry Allen:

I am the co-chairman of the Main Street Railroad Depot Committee. We do realize there is a joint driveway. The building is structurally sound per an engineer's inspection. We realize a lot of work must be done to rehab the building, but I firmly believe it is a viable project. I think it is worth preserving and the depot should be placed on the register.

Tom Prindle: My wife and I have a business in town. We've only been here 1 ½ years. We love the area. When we first visited the City, we walked the community and discovered a train depot, and were very attracted to it. I called Sue Leyda and wanted to buy the building but she told me there were other plans for it.

I am a train nut. Railroads and trains have been a part of our family for as long as I can remember. The building is a little rough, but I'm a contractor and I see the potential. If you tear it down, you'll lose a part of history, a part of Richland Center. Once it is torn down, it's a piece of history gone forever. It think it should be designated.

President Bower: Is there anyone else who would like to speak?

Judy Bethke: I am the Executive Director of Richland County Economic Development. I was born in in Richland Center and am hooked on history. It is hard to find links to your past and it the depot is a link to our past and it should be preserved.

Bill McCorkle: The heritage of Richland Center is commerce. This is one of the first times I have heard that mentioned and I agree with Madonna. I know how difficult it is to preserve old buildings since my family used to own some older buildings. I think the depot is the only thing left in town that still reflects the heritage of commerce and to lose it would be sad.

President Bower: Would anyone else like to speak?
