HISTORIC PRESERVATION COMMISSION MINUTES FOR 27 JANUARY 2009

Present: Bower, Shannon, Mueller, Andreae, Marshall, Jelinek, and Applicants Cheryl Stanley & Beata Elliott.

Absent: Moser

President Bower called the meeting to order at 7:05 PM.

Shannon moved/ Jelinek 2^{nd} to approve the 22 December 2008 Minutes as printed. Motion unanimously approved.

President Bower opened the Public Hearing by noting that the hearing had been properly noticed in the Observer and to the individual property owners.

We first considered the Fred H. Pratt home, which Cheryl Stanley currently owns. After brief discussion of the fantastic quality of this prairie school-style house, a listing on the Local Register was unanimously approved. [Mueller/Marshall]

Next, we considered Beata Elliott's application for her Robert C. Burnham house. Bower noted that the survey report erroneously listed Robert's father, John W. Burnham, as the builder of this home. Again, comment was made about the excellent condition of this prairie school-style house. Percy Bentley of LaCrosse was the architect for both the Pratt and Burnham homes, and for the City Auditorium. All three of these are now listed on the Local Register. The motion to list was unanimously approved. [Jelinek/Mueller]

Finally, we considered Jim Nelson's application for the Robinson Building, which is currently home of Nelson's Photography. Jim was unable to attend the hearing because his son, Matthew, had a basketball game. Richard Robinson was one of the businessmen who built the Court Street commercial district in the 1890s and early 1900s. Robinson built this building in 1917-18 as an investment, after he had retired from business. The longest tenent was the Coast-to-Coast store, which occupied the building from 1934 to 1977. Since then, Lou Coopey and Jim Nelson have had photography studios in the building. Again, the motion to list was unanimously approved. [Shannon/Andreae]

REPORTS:

Bower reported that he has contacted Terry Ryan about listing his building on South Central Avenue, which was originally the W. H. Pier Bank.

Mueller reported that he is prepared to soon contact the new owners of the Everson house.

Bower was empowered to call the next meeting when needed.
