## ORDINANCE #\_<u>QOQO-5</u> AMENDING WARD DESIGNATIONS IN ANNEXATION ORDINANCES 2019-14, 2019-15, AND 2019-16

(Well No. 8: Parcel 022-1723-1200) (West Reservoir: Parcel 022-2012-4000) (South East Reservoir: Parcel 022-2622-100)

WHEREAS, pursuant to Wis. Stat. § 66.0223, the Common Council of the City of Richland Center ("City") enacted Ordinance Numbers 2019-14, 2019-15, and 2019-16 ("Annexation Ordinances") on December 17, 2019 in order to annex three City-owned parcels of land located in the Town of Richland, Richland County, Wisconsin;

WHEREAS, each of the Annexation Ordinances contained mistaken ward designations; and

WHEREAS, the Common Council wishes to amend the Annexation Ordinances to correct the mistaken ward designations.

BASED ON THE FOREGOING: THE COMMON COUNCIL OF THE CITY OF RICHLAND CENTER, WISCONSIN, DO ORDAIN AS FOLLOWS:

SECTION 1. Section 5 of Ordinance 2019-14 is hereby amended to read as follows:

**Ward Designation.** The territory described in SECTION 1 is hereby made part of Ward 13 of the City and is subject to all rules and regulations governing the same.

SECTION 2. Section 5 of Ordinance 2019-15 is hereby amended to read as follows:

**Ward Designation.** The territory described in SECTION 1 is hereby made part of Ward 13 of the City and is subject to all rules and regulations governing the same.

SECTION 3. Section 5 of Ordinance 2019-16 is hereby amended to read as follows:

**Ward Designation.** The territory described in SECTION 1 is hereby made part of Ward 14 of the City and is subject to all rules and regulations governing the same.

<u>SECTION 4</u>. **Severability**. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision or application.

<u>SECTION 5</u>. **Effective Date**. This ordinance shall take effect as provided by law. Adopted by the Common Council of the City of Richland Center this 4<sup>th</sup> day of February, 2020. Except as
