## **CHAPTER 46**

## ESTABLISHING COMPENSATION FOR MEMBERS OF CERTAIN BOARDS, COMMISSIONS AND COMMITTEES OF THE CITY OF RICHLAND CENTER

[History: Ord 1988-18, 1997-2, 2010-2]

- **46.01 Compensation of Citizen Members of the Utility Commission.** Citizen members of the Utility Commission shall receive no salary, but shall be compensated on a per diem basis for meetings attended, according to the following schedule:
  - (1) Utility Commission Meetings. For attendance at a meeting of the Utility Commission: \$40.00
- (2) Other Meetings. For attendance at a meeting other than a Utility Commission meeting but which is related to utility business: \$30.00, provided that payment for any such meeting must be approved by the full Utility Commission. No member may be paid for attending more than one such other meeting on any one day.
- (3) Maximum Annual Payment. The maximum payment to any citizen member of the Utility Commission for meeting attendance shall not exceed \$2,000.00 in any calendar year for meetings attended in the year. Payment for all meetings attended by a citizen member in a calendar year shall be made in one payment at the end of the calendar year. [Amended by Ord 2010-2]

- **46.03 POLICE AND FIRE COMMISSIONERS.** The compensation for each member of the Board of Police and Fire Commissioners shall be \$300.00 per year, payable in one installment not earlier than October 1 nor later than December 31.
- **46.04 HOUSING AUTHORITY COMMISSIONERS.** The compensation for each member of the Board of Commissioners of the Housing Authority shall be \$300.00 per year, payable in one installment not earlier than October 1 nor later than December 31.
- **46.05 BOARD OF PARK COMMISSIONERS.** The compensation of each citizen member of the Board of Park Commissioners shall be \$10.00 per diem for each day upon which a meeting of the Board is actually attended by the Commissioner, up to a maximum allowable per diem of \$150.00 per calendar year.
- **46.06 LIBRARY BOARD.** The compensation of each citizen member of the Library Board shall be \$10.00 per diem for each day upon which a meeting of the Board is actually attended by the Board member, up to a maximum allowable per diem of \$150.00 per calendar year.
- **46.07 ZONING BOARD OF APPEALS.** The compensation of each member of the Zoning Board of Appeals shall be \$10.00 per diem for each day upon which a meeting of the Board is actually attended

by the Board member, up to a maximum allowable per diem of \$150.00 per calendar year.

- **46.08 CITY PLANNING COMMISSION.** The compensation of each citizen member of the City Planning Commission shall be \$10.00 per diem for each day upon which a meeting of the Commission is actually attended by the Commission member, up to a maximum allowable per diem of \$150.00 per calendar year. The President of the Park Board, as an ex-officio member of the Planning Commission, shall be entitled to the said per diem as a Planning Commission member in addition to the per diem under sec. 46.05 for services as a Park Board member, provided such President is a citizen member of the Park Board.
- **46.09 JOINT EXTRATERRITORIAL ZONING COMMITTEE.** The compensation of each of the City's three citizen members of the Joint Extraterritorial Zoning Committee shall be \$10.00 per diem for each day upon which a meeting of the Committee is actually attended by the Committee member, up to a maximum allowable per diem of \$150.00 per calendar year, provided that if the Joint Extraterritorial Zoning Committee meeting is held immediately before or immediately after a meeting of the City Planning Commission, the member may be paid only one per diem for attending both meetings.
- **46.10 REVOLVING LOAN FUND COMMITTEE.** The compensation of each of the citizen members of the City Revolving Loan Fund Committee shall be \$10.00 per diem for each day upon which a meeting of the Committee is actually attended by the Committee member, up to a maximum allowable per diem of \$150.00 per calendar year.
- **46.11 CEMETERY COMMITTEE.** The compensation of each of the citizen members of the City Cemetery Committee shall be \$10.00 per diem for each day upon which a meeting of the Committee is actually attended by the Committee member, up to a maximum allowable per diem of \$150.00 per calendar year.
