RESOLUTION 2014-9

A RESOLUTION AUTHORIZING IMPLEMENTATION AND FEES FOR THE LARGE WASTE ITEM COLLECTION TAGGING **SYSTEM**

WHEREAS, the City Council did on November 5, 2013, enact Ordinance 2013-15 Amending Chapter 335 of the Code of Ordinances to create Section 355.09 of the Code of Ordinances: Collection and Disposition of Large Household Items; Tagging System,

AND WHEREAS, the City Council did on March 18, 2014, enact Resolution 2014-7 authorizing implementation and fees for the large waste item collection tagging system;

AND WHEREAS, additional information has subsequently come to the City necessitating refinement of the procedures set up by Resolution 2014-7, now, therefore,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF RICHLAND **CENTER**, as follows:

- (1) The City Council does authorize the implementation of the large item collection tagging system and directs the City Clerk/Treasurer's Office to distribute tags/stickers and proceed with the collection process outlined herein.
- (2) The following fees are established for the pickup and disposal of the listed items pursuant to a tag/sticker purchased in advance by the property owner or tenant:

- (3) The prices listed above shall apply to residents or property owners who purchase appropriate tags/stickers in advance.
- (4) In the event a tag/sticker has not been purchased and item(s) are placed out near the curb without a tag/sticker, the City may issue tags/stickers for the untagged items so placed. The cost of such tags/stickers issued by the City for untagged items placed out near the curb without a tag/sticker shall be twice the amounts set forth above for advance purchase of tags/stickers and, in addition, there is imposed an additional two hundred fifty dollar (\$250.00) administrative fee.
- (5) The City shall thereafter bill the property owner for the cost of such tags/stickers as set forth herein plus the administrative fee. The billing shall be sent by 1st class mail to the owner of the property or recipient of record for real estate tax bills for the property from which the items are removed at the address as set forth in the records of the Richland County Treasurer for the mailing of real estate tax bills for the property. The cost of such tags/stickers and administrative fee shall be a special charge against the real estate from which the items are removed. Such billing shall include or be accompanied by a notice that the billing represents a special charge against the subject real property.
- (6) If a special charge is not paid within sixty (60) days after such mailing, the special charge is delinquent. A delinquent special charge becomes a lien on the property against which it is imposed as of the date of delinquency. The delinquent special charge shall be included in the current or next tax roll for collection and settlement under ch. 74 Wisconsin Statutes.
 - (7) This Resolution supersedes Resolution 2014-7.

(8) This Resolution shall be effective May 1, 2014
