ORDINANCE NO. 2018-2

AN ORDINANCE RENUMBERING 399.04(1)(f)3 TO 399.04(1)(k) AND AMENDING 399.04(1)(k) RELATING TO TEMPORARY LICENSES FOR WINE WALKS AND CREATING 399.04(1)(l) PROVIDING FOR TEMPORARY LICENSES FOR BEER WALKS

The Common Council of the City of Richland Center, Wisconsin, does ordain as follows:

SECTION 1:

Subparagraph 399.04(1)(f)3 is renumbered 399.04(1)(k) and amended to read:

(k) Single Day Temporary "Class B" Wine Only License for Multiple Locations (Wine Walks).

The City may issue up to 20 single day temporary "Class B" wine only licenses for multiple locations to any of the following qualified organizations: bona fide clubs; state, county or local fair associations or agricultural societies; churches; lodges or societies that have been in existence for at least 6 months before the date of application; posts of veterans organizations or chambers of commerce or similar civic or trade organizations organized under chap. 181 Wisconsin Statutes, if all of the following apply:

- 1. Each license is issued to the same qualified organization who is the sponsor of an event held at multiple locations within the City on such date and at such times.
- 2. An admission fee must be charged for participation in the event and no additional fee may be charged for service of wine at the event.
- 3. Within the immediately preceding 12-month period, the City has issued licenses under authority of this paragraph for fewer than two (2) events. For purposes of such 2-license limit each event for which multiple licenses are issued shall count as one license toward the 2-license limit. A qualified organization may receive temporary "Class B" wine only licenses for up to two (2) events during a 12 month period.
- 4. The duration of an event under this subparagraph may not exceed one day.
- 5. No person may serve wine after 9:00 P.M. on premises covered by a temporary "Class B" single day wine license for multiple locations.
- 6. The City Council or an official or body authorized by the City Council to issue temporary "Class B" wine licenses may, upon issuance of a temporary "Class B" wine only license for multiple locations, authorize the licensee to permit unaccompanied

underage persons holding a valid driver's license to be on the licensed premises for the purpose of acting as designated drivers, provided such underage persons have been provided a means of identification, such as a wristband, by the licensee.

SECTION 2:

Subparagraph 399.04 (1) I is adopted to read:

(l) Single Day Temporary "Class B" Fermented Malt Beverage License for Multiple Locations (Beer Walks).

An unlimited number of single day of single day "Class B" Fermented Malt Beverage Licenses For Multiple Locations may be issued to any of the following qualified organizations: bona fide clubs; state, county or local fair associations or agricultural societies; churches; lodges or societies that have been in existence for at least 6 months before the date of application; posts of veterans organizations or chambers of commerce or similar civic or trade organizations organized under chap. 181 Wisconsin Statutes, authorizing the sale of fermented malt beverages at a particular picnic or similar gathering or at a meeting of the post if all of the following apply:

- 1. Each license is issued to the same qualified organization, who shall be the licensee and sponsor of an event to be held at multiple locations within the City on the stated date and at the stated times.
- 2. The licenses shall all be issued for the same date and time.
- 3. An admission fee must be charged for participation in the event and no additional fee is charged for service of alcohol at the event.
- 4. The duration of an event under this subparagraph may not exceed one day.
- 5. No person may serve beer after 12:00 A.M. (midnight) on premises for which temporary Class "B" beer licenses have been issued for a single-day multiple-location event.
- 6. The City Council or an official or body authorized by the City Council to issue temporary "Class B" wine licenses may, upon issuance of a temporary "Class B" fermented malt beverage license for multiple locations, authorize the licensee to permit unaccompanied underage persons holding a valid driver's license to be on the licensed premises for the purpose of acting as designated drivers, provided such underage persons have been provided a means of identification, such as a wristband, by the licensee.

SECTION 3: EFFECTIVE DATE.

This ordinance shall be in full force and effect from and after its passage and publication.
