ORDINANCE 2017 - 3

ANNEXING CERTAIN LANDS OWNED BY PANORAMA ESTATE LLC

The Common Council of the City of Richland Center, Wisconsin, does ordain as follows:

SECTION 1: TERRITORY ANNEXED.

In accordance with Section 66.0217(2), Wisconsin Statutes, and the petition for annexation filed on December 1, 2015, with the City Clerk/Treasurer, the following described lands owned by Panorama Estate LLC are hereby detached from the Town of Richland and annexed to the City of Richland Center:

Lot One (1) of Richland County Certified Survey Map No. 1014, recorded January 14, 2016, in Volume 9 of Certified Survey Maps on Pages 137-138 as document number 311191 in the office of the Richland County Register of Deeds.

Said land is located in the Southeast Quarter (SE 1/4) of the Northwest Quarter (NW 1/4) and the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section 17, Township 10 North, Range 1 East, Town of Richland, Richland County, Wisconsin.

SECTION 2: EFFECT OF ANNEXATION.

From and after the effective date of this ordinance, the territory described in Section 1, which has a current population of zero (0), shall be a part of the City of Richland Center for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Richland Center. The annexed territory shall be placed in the 10th ward.

SECTION 3: ZONING CLASSIFICATION.

Upon annexation, the said lands shall be temporarily classified as R-5 Five or More Family Residential, pursuant to Section 66.0217(8) Wisconsin Statutes.

SECTION 4: PAYMENT TO THE TOWN OF RICHLAND.

Pursuant to Wis. Stat. sec. 66.0217(14)(a), the Common Council agrees to pay annually to the Town of Richland, for five (5) years, an amount equal to the amount of property taxes that the town levied on the annexed territory, as shown by the tax roll under Wis. Stat. sec. 70.65 for the year 2016.

SECTION 5: EFFECTIVE DATE.

This ordinance shall be in full force and effect from and after its passage and publication.

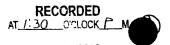

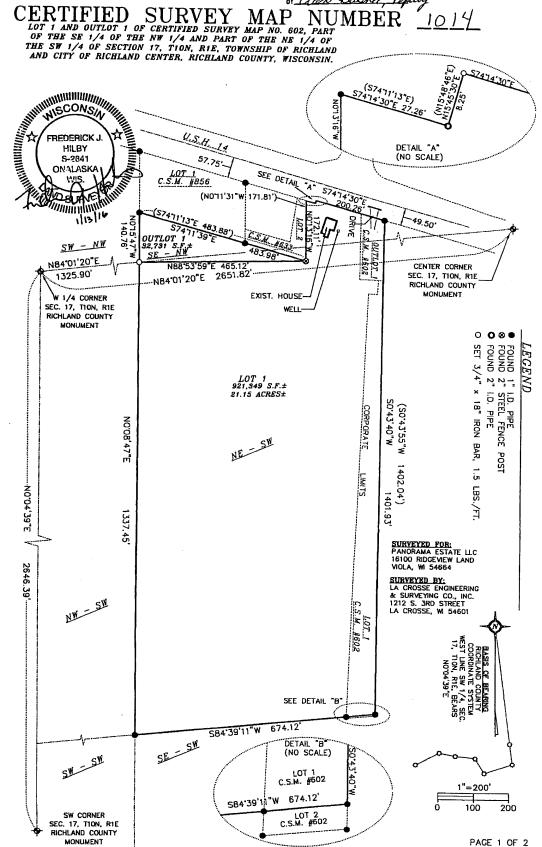
